

WINNESHIEK COUNTY ROAD DEPARTMENT

DUST CONTROL PERMIT

*** Applications need to be received in the Engineers Office by May 1, 2017 ***

The approval of this application is to apply up to two treatments of dust control on a (minimum 400 feet) portion of county rock road centered at the drive located at (911 Address)_____.

Applicant will stake the limits of the dust control with painted lath or conspicuous non-obstructing flags and maintain any and all potholes and irregularities in the treated road segment, to the satisfaction of the county.

Dust control applicators will handle the filling out of permits, collect fees, send copies to Winneshiek County, notify Winneshiek County of applications on file, apply the treatments once the roadway has been approved for application by the County, and answer questions from applicants.

Winneshiek County will furnish painted lath (upon request) for the applicant to use in staking the limits of the dust treatment. Lath can only be removed by the county. Winneshiek County shall also maintain and shape the road prior to each application. Any treated roadway section may be maintained by the county starting October 1st in preparation for winter. If pot holes develop at any time within the treatment limits, maintaining by applicant or county will be done using normal roadway maintenance practices and materials.

All first applications shall be applied during last full week of May through the first full week of June unless due to weather conditions or special circumstances. Single and second applications shall be applied as necessary. Two or more "single" applications will not be allowed. Detour, haul road and other special condition dust control permits shall be applied as needed. Winneshiek County does not guarantee any time frame for approval of second applications.

Iowa law specifies, "the purpose of a public highway is to serve the traveling public". Please Note: Dust treatments after October 1st or those left rough and unmaintained by applicant MAY be scarified and maintained as a rock surface by the county. Winneshiek County will attempt to give notice to the applicant of need for maintenance but reserves the right to waive any notice if deemed necessary.

NOTE: Please place the colored lath at the spot you want your dust control to start and end. Please ensure that your E911 address is prominently displayed at the end of the driveway/entrance so we can be sure we have the correct location. If there are no visible stakes at the location of dust control, the county will not approve the location for application of dust control.
